

**Abram Lancaster**  
**(c. 1836-1904)**  
**Civil War**

Abram Lancaster served as a Private, Corporal, and Sergeant in the Thirty-third US Colored Troops of the US Army in the Civil War. Born in Saint Augustine, Florida, Lancaster lived and worked there prior to his military service. Afterwards, he returned to Saint Augustine where he died in 1904. Lancaster is buried in the Saint Augustine National Cemetery.


