
## William Plummer (1873(?)-1936) Spanish American War

William Plummer served as a Private in the Twenty-Fourth Infantry during the Spanish American War. He was living in Saint Augustine, Florida, prior to his military service. Afterwards, he returned to Saint Augustine where he worked and lived with his wife Dora. Plummer died in 1936 and is buried in the Saint Augustine National Cemetery.








"William Plummer." 1900 US Federal Census.

Plummer (line 87), census was taken of the Company F, Twenty-fourth Infantry while staying in the Philippines.








"William Plummer." Register of Enlistment.

Discharged on October 9, 1901.








"William Plummer." Pension Record.

Plummer died February 21, 1936 of Labor Pneumonia.






