

"Of interest to friends here is the marriage of Miss Caroline Veronica Van Deinse, daughter of Mr. and Mrs. A.F. Van Deinse of Orlando, Fla., formerly of Marion, to Charles Ernest Perez of New York City, which is now being announced today by the bride's parents. The ceremony took place in New York City, Friday noon. The bride has made her home in Orlando for the last seven years, going to that city with her parents from Marion. She graduated from the Ida M. Fisher High school at Miami Beach, Fla., and the Junior College for Girls at Tudor Hall in Indianapolis. Mr. Perez is the son of Charles Perez of Key West, Fla., and brother of Mrs. William Atkinson of Orlando, whom he has visited frequently. He is employed in the transportation department of the New York City post office. Mr. and Mrs. Perez will make their home in New York City."


