
## Nelson Mullin 1887-1944 World War I

Nelson Mullin served with the 522<sup>nd</sup> Engineer Battalion of the US Army during World War I. Born in Camilla, Georgia, Mullin worked as a laborer prior to his military service. Mullin died in 1944 and is buried in the Saint Augustine National Cemetery.
