World War I

Arthur Tomlinson served as a Private in the Headquarters, 350th Field Artillery Regiment, Ninety-second Infantry Division, in World War I. He lived in Saint Augustine, Florida, with his family prior to his military service. Afterwards, he returned to Saint Augustine and worked as a laborer. Tomlinson died in 1926 and is buried in the Saint Augustine National Cemetery.
