William Wilkerson served in the 508th Engineer Service Battalion of the US Army during World War I. Born in Atlanta, Georgia, Wilkerson worked as a laborer in Pennsylvania prior to his military service.

Afterwards, he moved to Los Angeles, California. Wilkerson died in 1940 and is buried in the Saint Augustine National Cemetery.
